

## **HOME RULE RESOLUTION NO. HR-90-11**

**WHEREAS**, the Board of County Commissioners of the County of Shawnee, Kansas, has adopted Home Rule Resolution No. HR-84-7, as amended by Home Rule Resolution No. HR-87-12, which allows residents of platted subdivisions located within the unincorporated areas of Shawnee County to petition the Board of County Commissioners to impose a prohibition on dogs roaming at-large within the boundaries of the platted subdivisions; and,

**WHEREAS**, the Partial Replat Shawnee Meadows Subdivision and the Shawnee Meadows Subdivision, which are located in unincorporated Shawnee County, have presented petitions which have been verified by the Shawnee County Clerk as having been signed by more than sixty percent (60%) of the real property occupants and/or owners in each of the above-listed subdivisions to the Board of County Commissioners pursuant to Section II of HR-84-7, as amended by HR-87-12; and,

**WHEREAS**, a public hearing was held by the Board of County Commissioners on October 18, 1990, after three calendar days' notice of the hearing was published in the official County newspaper; and,

**WHEREAS**, all interested parties were afforded ample opportunity to be present at the hearing and to discuss the proposed implementation, in the above-listed subdivision, of HR-84-7, Section III, Paragraph I, as amended by HR-87-12.

**NOW THEREFORE**, the Board of County Commissioners of the County of Shawnee, Kansas, meeting in regular session on this 18<sup>th</sup> day of October, 1990, and intending to exercise its powers of home rule legislation pursuant to K.S.A. 19-101a, does hereby resolve as follows:

**ORDER**

1. It is in the public's health, safety and welfare interests to enact and prescribe regulations for the control of dogs within the Partial Replat Shawnee Meadows Subdivision and the Shawnee Meadows Subdivision.

2. Effective upon publication of this resolution once in the official County newspaper, it shall be unlawful for any dog to be at-large within the platted boundaries of the Partial Replat Shawnee Meadows Subdivision and the Shawnee Meadows Subdivision, as prohibited by the provisions of HR-84-7, Section III, Paragraph I, as amended by HR-87-12. The owner of any dog found to be at-large within the platted boundaries of the Partial Replat Shawnee Meadows Subdivision and the Shawnee Meadows Subdivision, will be held strictly liable therefore.

3. Any person found to be in violation of HR-84-7, Section III, Paragraph I, as amended by HR-87-12, shall be deemed guilty of a misdemeanor and, upon conviction or a plea of guilty therefore, may be fined a definite sum of money not to exceed Two Hundred Fifty and No/100 Dollars (\$250.00).

4. This Home Rule Resolution specifically recinds Home Rule Resolution No. HR-90-8 and all previous resolution in conflict herewith.
